- hereinafter referred to as the "**Contractor**" or "**Authorized Representative**" or "**ICCA**" -

On the basis of the Austrian Waste Management Act (*AWG 2002*) the Austrian Packaging Regulation (*Verpack-VO*), the Austrian Regulation on Waste Electrical and Electronic Equipment (*EAG-VO*) and the Austrian Regulation on Batteries (*Batt-VO*) provide that foreign mail order companies or foreign distance sellers of packaging, single-use plastic products, electrical and electronic equipment (EEE) or batteries are required to name an Authorized Representative for Austria and that foreign producers of such products may name an Authorized Representative who carries out registration in a producer register on their behalf and who is responsible for fulfilling the obligations of the foreign distance sellers/mail order companies or foreign producers.

As an Authorized Representative ICCA assumes the Customer's obligations under the *AWG 2002*, the *Verpack-VO*, the *EAG-VO* and the *Batt-VO* in connection with the placing on the market of packaging/single-use plastic products/electrical and electronic equipment /batteries. For this purpose, the parties agree as follows:

1. For the purpose of Sections 16a, 16b, 16c and 16d *Verpack-VO*, Sections 21a and 21b *EAG-VO*, Sections 25a and/or 25b *Batt-VO*, the Customer delegates the fulfilment of their obligations as a foreign producer or foreign mail order company/foreign distance seller to ICCA as the sole Authorized Representative.

2. The authorization relates to the following area:

4. In particular, the authorization includes the following rights and obligations of the Authorized Representative.
- a. registration as an authorized representative in the register pursuant to Section 22(1) *AWG 2002* including the data pursuant to Section 16a(2) No. 1, Section 16b(3) No. 1, Section 16c(2) No. 1 and Section 16d(3) No. 1 *Verpack-VO*, pursuant to Section 21(1) Nos 1 to 9 *EAG-VO* and pursuant to Section 22(1) Nos 1 to 7 *Batt-VO*;
 - b. transfer of the registration data for each contractor separately and the scope of authorization to the register pursuant to Section 22(1) *AWG 2002*;
 - c. information of every primary obligor pursuant to Section 13g(1) Nos 1 to 4 *AWG 2002* (packaging), every producer concerned pursuant to Section 12a(4) No. 1 and (5) No. 1 *AWG 2002* (single-use plastic products), every producer concerned pursuant to Section 12a(1) No. 3 *AWG 2002* (EEE) and every producer concerned pursuant to Section 12a(2) No. 1 *AWG 2002* (batteries) on the type and scope of the authorization and on any changes thereto as well as on the masses of

Annex 1 to Authorized Representative Contract

- packaging/single-use plastic products/electrical and electronic equipment/batteries concerning them for which the foreign producer is responsible (only for "foreign producers");
- d. transmission of a list of the primary obligors concerned pursuant to Section 13g(1) Nos 1 to 4 AWG 2002 (packaging), the producers concerned pursuant to Section 12a(4) No. 1 and (5) No. 1 AWG 2002 (single-use plastic products), the producers concerned pursuant to Section 12a(1) No. 3 AWG 2002 (EEE) and the producers concerned pursuant to Section 12a(2) No. 1 AWG 2002 (batteries) to the competent register (only for "foreign producers");
 - e. report of any discontinuation of the activities of the authorized person or the Authorized Representative by way of the register pursuant to Section 22(1) AWG 2002; and
 - f. report on the placing on the market, collection and treatment, separately for every authorising entity, to the competent register or the relevant collection and recovery system.
5. The fulfilment of obligations under all Community legislation on the restriction of the use of certain hazardous substances in electrical and electronic equipment (see in particular RoHS Directive 2011/65/EU) is in any case not covered by the authorization.
 6. The Customer warrants that the Authorized Representative will be provided with all documents necessary for fulfilling their tasks and that they will be notified of any changes to the data immediately.
 7. The Customer grants the Authorized Representative the right to conclude contracts that are binding on the Customer in connection with their obligations under the *Verpack-VO*, the *EAG-VO* and/or the *Batt-VO* and to change or terminate such contracts.
 8. The Authorized Representative expressly agrees to assume the above obligations.
 9. This Power of attorney shall be granted for an indefinite period of time. In principle, the power of attorney shall end upon termination of the Authorized Representative Contract with no separate notice of termination being required with respect to the power of attorney.
